PERMIT GUIDELINES

**Captree, Fire Island and Sexton Island Year Round Residents
Overnight Parking at Captree State Park and Robert Moses State Park - Field #5**

ANNUAL PERMIT FEE: \$400.00 PER VEHICLE

PLEASE MAKE CHECK PAYABLE TO: O.P.R. & H.P. – L.I. REGION

1. Permit must be affixed to the driver's side rear left bumper.
2. Permit valid for overnight vehicular use only. Permittee agrees that the Long Island State Park Region assumes no liability for any damage or theft that might occur during the use of this permit. No bailment is created.
3. Vehicles may not be left for more than five (5) consecutive days.
4. Permittee must provide valid proof of residency to obtain permit. (Captree Island residents must prove year-round residency.)
5. Permit does not constitute a waiver of the daily park vehicle use fee.
6. All permittees must park in the east side of the parking field.
7. Permit is subject to immediate rescission should permittee breach any of the rules herein or any of the rules and regulations or State Park Laws.
8. Only a limited number of permits are available. Permits will be issued on a first come, first served basis to qualified applicants only. No more than two (2) permits issued per household.
9. Permittee is not permitted to berth boat overnight at the Captree Boat Basin or boat launch ramp dock.
10. Valid April 1, 2020 to March 31, 2021, at Captree State Park. Valid October 1, 2020 to April 30, 2021, at Robert Moses State Park – Field #5. Not valid at any other times or at any other locations.
11. Violation of any condition of this permit or any rule of STATE PARKS or the Long Island Park Region may result in the immediate revocation of the permit (NO REFUND) and POSSIBLE ISSUANCE OF A TICKET. Permit will be revoked for 1 year from date of revocation.

REPLACEMENT DECALS WILL BE PROVIDED ONLY UNDER THE FOLLOWING CONDITIONS:

- A. **Lost or stolen decals:** A police report must accompany all requests.
- B. **Sold or leased vehicles:** Proper documentation is required from Dept. of Motor Vehicles.
 1. Write down the number of the decal and peel or scrape off all pieces.
 2. Bring the # and pieces of the sticker to the Permits Office for a replacement.
No replacements will be issued without the pieces of the original permit
